Go Back on Their Agreement. Fond du Lac, March 12.—[Special.]—In spite of the agreement of the Wisconsin Central engine men of the northern division to abide by the decision of the general assembly, the break in the road on the road in the matter of the grievances of the Fond du Lac engine men, it is claimed that the northern men have made a protest to General Supt. As a candidate for the Minnesota legislature provides for the payment of \$10 for county or local nominations, a \$20 fee for candidates for office voted for in more than one county, and a \$50 fee for candidates for state offices. But the legislators of the Gopher state likely will find the bill contrary to the fundamental principles of our national form of government, in that it makes one's candidacy for office conditional upon the amount of money he is willing to put up. The bill would encourage bootlegging, also, as if the price of the candidacy for an office can be made \$50 it might then be raised so that only "the man with a bundle" could run for it. If the people of Minnesota want to hold their caucuses and elections at the expense of the candidates, the bill should be killed on the ground that it would "tax the few for the benefit of the many." At any rate, lack of money should bar one's candidacy for office no more than it prevents him from voting. But, perhaps if the author of the Minnesota bill had thought of it, he would have inserted "and every voter shall deposit 1c with the election clerk upon applying for an Australian ballot, as the paper alone is nearly worth the price."
