NO CHANCE TO ESCAPE.
Ten Persons Lose Their Lives by Fire in Boston Tenement.
Boston, Jan. 29.—Ten persons dead, three seriously hurt in jumping from windows and others more or less hurt was the result of a fire just before 2 o'clock this morning in an Italian tenement house on Fleet street, North End. Nine of the dead are adults, three of them women and the tenth is a child.
The building was four stories in height. The fire was not seen until it had reached the top floor, where it was on the upper floor was cut off. Before the firemen got to the scene two women and a child had jumped from the windows of the third floor to the street below.
The firemen had succeeded in subduing the flames by a search of the rooms and found ten bodies. The women and child officers labored hard in giving the unfortunate emergency treatment, but their efforts were in vain for all had inhaled flames and smoke, and their bodies in most cases were blistered by the fierce heat which they had encountered.

AMERICANS SUFFER BY REBEL TREACHERY
Soldiers Rendered Delirious by Lack of Food—Discovered in Trees, Barking Like Dogs.
Manila, Jan. 29.—The ten men of Capt. Porter's force of marines, who had been given up as dead, arrived in camp yesterday in a most pitiable condition, delirious from privation and suffering. Several cannot recover.
These marines, however, were in little worse condition than the twenty-seven of the party who returned from their expedition into the interior of Luzon a week ago. Details of the expedition's hardships and the treachery of the natives and the awful tortures to which the men were reduced.
The natives who accompanied the marines claimed they were unable to distinguish the edible roots which the marines did not believe. The anger of the marines against the natives was increased by the fact that the latter returned with the marines.
The marines suffered so acutely from starvation that they ate, raw, the excrement of two dogs.
When Capt. Porter and the first three of his men started on their march, they were delirious, and difficulty was experienced in ascertaining the whereabouts of their companions.







The inquest on the remains of Frank Krueger, who came to his death from injuries received by being run over on the Duntion railroad crossing, two miles south of this village, on the 18th inst., was held here before Justice Wraacke at 10 a. m., last Monday. The jurors were: John Loeb, Wm. Wedde, Fred Borchert, L. C. Kohler, Eugene Van Epps and M. L. McCullough. The jury rendered the following verdict: We find that the deceased, Frank Krueger came to his death from injuries received by a Chicago & Northwestern passenger train, at Duntion's crossing; train No. 58, on Jan. 18, 1902, between the hours of 6 and 7 o'clock p. m. R., No. 246, and at the time of death was commander of the Post. Mr. Yankow was also a member of the town board and held the office of supervisor at the time of his death. Decedent leaves a wife and nine children: Fred Jr., of Milwaukee; Clara, (Mrs. Wachler) of Plymouth; Chas., (Mrs. George, Hattie, (Mrs. Spoerl) Arthur, Emma and Alvin, living here. The funeral was held from the M. E. church last Thursday, with Rev. Trautman, of Lorima, and Rev. Mallett, of this place officiating; with interment in the Union cemetery.
