Suffered from Heart Troubles.

Some two years ago Mr. Johnston was informed by a physician of the fact that he had a heart affection, which discovery was made in connection with an application for an increase of life insurance.

THE LATE JOHN JOHNSTON.

John Johnston was a prominent figure in the business, social and intellectual life of Milwaukee. He was a member of the board of regents of the Wisconsin university, serving for several years as president.

Suffered from Pneumonia.

Two weeks ago Mr. Johnston suffered ordinary pneumonia which, under treatment, would not have been serious.
