DAVIDSON A CANDIDATE.

ANNOUNCES THAT HE WILL TRY TO SECURE THE REPUBLICAN NOMINATION. FAVORS 2-CENT FARE.

Outlines His Platform on Which He Counts for Popular Approval. MADISON, Wis., April 30.—[Special.]—No backward step must be taken in the legislation of the last six years, says Gov. James O. Davidson in an announcement of his candidacy for the nomination for governor.

These, he said, may be the planks of his platform on which he will go before the people. The statement sets forth that Gov. Davidson succeeded La Follette on New Year's day and that he feels it a duty to himself and his friends to run his work and policies may be carried out.

A review of Gov. Davidson's services as assemblyman, state treasurer, and lieutenant governor also are given, with particular attention to Davidson's loyal support and cooperation with La Follette in bringing about reforms of recent years. Davidson pays a high tribute to La Follette, and is emphatic in his declaration that no retrograde step can be taken and that the people must be alert to prevent any such step.

Other Candidates in Field. Two other avowed candidates are in the field for the Republican nomination. Spenser Irvine L. Leacock, a prominent banker and real estate dealer, and the backing of Senator La Follette and a majority of the legislature, are expected to back a campaign on the issue that the La Follette reforms must be safeguarded and extended.

Davidson's Announcement. In response to numerous and urgent requests from citizens in all parts of the state before the annual meeting of the Republican party, I have decided to accept the nomination for the office of governor.

While treasurer of the state I labored faithfully to have the money work of the state put on a sound basis. I have secured the treasury large sums of interest earned on the state funds, and have secured the state funds were invested without the loss of a dollar.

Believing he had killed the girl, Chanava fled, and the last seen of him he was going south, with Chief of Police Pfister and other officers close after him. Chanava was chased by three squads of police along East street, where he was captured.

Worth Remembering.
