To Parents, School Boards and Teachers.

In order that the provisions of the compulsory attendance law, Chapter 446, Laws of 1907, may not be intentionally violated by those who are affected by it, its main provisions are herewith summarized:

1. All children between 7 and 14 must attend some public, parochial or private school, six months in towns and villages and eight months in cities.

2. All children between 14 and 16 must attend the same time, unless they are granted a permit to work by some judge, factory inspector or commissioner of labor.

3. Regular attendance is required 20 days each month, holidays excepted.

4. Pupils must be enrolled within one month after school opens.

5. Children excused from compliance with the law: (a) graduates of common and graded schools, (b) those physically unable holding the required physician's certificate, (c) those living more than two miles by nearest travelled road from school house, (d) those receiving equivalent instruction elsewhere.

6. Parents or guardians not complying with the law are subject to a fine of from 5 to 50 dollars and costs of prosecution, or to not exceed three months in jail, or by both fine and imprisonment. Every day's absence is an offence.

7. The District Attorney must prosecute all offenders.

8. In cities under 2000 and in towns and villages the Sheriff and his deputies are the trustee officers.

9. District Clerks must make three copies of the school census of their district, send one to the Town Clerk, one to the County Superintendent and give one to the Teacher. For failure to do this the Clerk is liable to a fine of from 5 to 25 dollars.

10. The teacher must report to the County Superintendent the names and ages of all children enrolled in their respective schools between the ages of 7 and 14 and between 14 and 16; the names and post-office addresses of the parents or other persons having control of such children; the number of the district and the name of the town or village and county in which such children reside; the distance such child or children reside from the school house in the district in which they live by the nearest travelled road; the number of days such child was present; and the number of days such child was absent during each month.

11. The County Superintendent must then notify the Sheriff or other trustee officer of all who are not complying with the law.

12. It is then the duty of the Sheriff or other trustee officer to notify the parents or guardians to put children in school and if they fail to do so he shall enter complaint against them, and the District Attorney must then prosecute them.

The persons to whom is delegated the carrying out of this law have no choice in the matter. They must do their duties as outlined by law or render themselves liable to a fine or removal from office. The object of the law is not to punish the parents but to get the boys and girls in school. To this end let us all cooperate, and I trust that the penalty of the law will not have to be evoked in a single instance. I am,






