JAPANESE RIOT AT VANCOUVER

HOST OF ORIENTALS POUNCE ON THREE FIREMEN AND STAB THEM FRIGHTFULLY.

DOZENS ATTACK WHITE MEN.

Uniform Is No Protection After One Canadian Accidentally Falls Into Plate Glass Window.

ONLY FOUR ARRESTS ARE MADE.

VANCOUVER, British Columbia, Jan. 2.—Allen Anderson, a fireman, is dying and two other young men also members of the fire department are badly wounded as the result of a fight yesterday in the Japanese quarter with an overwhelming number of subjects of the Mikado. The fight was the worst in the city since the September riots.

Japs Swarm Like Bees. Anderson, accompanied by J. Frost and T. McDonald, were passing a Japanese store when they were pelted with hard glass against the plate glass window front. The glass smashed and the fragments were still rolling on the sidewalk when a score of the rioters, who were dressed in white, rushed at the trio of whites. The firemen were in uniform with brass buttons and caps, but the Japanese knifed them furiously. Within three minutes there were dozens of Japanese attacking the white men on the sidewalk and on the street. Only four arrests were made, as nearly all the Japanese escaped at sight of the police.

Men Frightfully Stabbed. Anderson's two companions thought Anderson dead and were fighting over his prostrate body when the police came. Anderson's face was marked with many slashes up and down and from one side to the other. From the back of his head a fracture of an inch, the body deep that had only missed the jugular vein by a fraction of an inch. The body was washed in half a dozen places. The other two men were cut and bleeding from wounds on their faces and arms.

The steamer was reported to have been in the vicinity of Sable Island, but was not sighted until it was seen on the same course as it was steaming, but moving slowly. California, a Winter Paradise

IT SOMETIMES RAINS IN PARADISE (By William Henry Forber.)

This is the rainy season here, and the mud is just as muddy as Eastern mud; for mud is dust mixed with water; and unpaved roads are in a horrible condition now, but I will admit that the summer roads are certainly fine, especially those sprinkled with crude oil, and oiled roads are in very good shape even in the wet season, as oiled earth does not absorb water as readily as unoled dust.

HEALTH.

Eastern people are often told that California is a healthy state. Now I am not a knocker, neither am I a booster, I wish to acquaint those who may seek information with the actual conditions as they really exist here. I hear more people hacking and coughing and sneezing here than I have ever heard in the east. One reason may be assigned for this that the so-called "lungers" come here on account of the milder climate. Another reason is that people do not dress as well or as warmly and comfortably here as in the east; while the nights are usually very chilly or just a few degrees from a frost, the frosts are very rare except in the higher altitudes. I have attended lodges where at least 15 per cent of the membership were reported as being on the sick list, but there are reasons for this. Many of the towns have drinking water which is not fit for beasts. This is the case with all of the larger towns, and while the mountain lakes have the best and purest of water the city water supply is often taken from an irrigation ditch through which cattle wade and in which some die and are left to decay, or the water is taken from some turbid river to which the Milwaukee river at Kewaskum might be called a limpid brook. I stopped at a mushroom town a few days ago in which 17 cases of diphtheria had just made an appearance and the entire population thought that the germ was in the air, while their drinking water was really at fault and showed nitrates and dead animal and mineral matter. Many of the "daggers" were inclined to blame the stars. This is about as sensible as to blame the air. Malaria is a very prevalent disease here. Nearly everyone lays it to the air, fog and water, but the cause is the ANAPHLES mosquito. Typhoid fever is also prevalent. A germ in the drinking water is usually the cause, but flies are a very resourceful carrier of disease germs. There are myriads of flies and mosquitoes here at all times of the year and those who live in the tents or live in shacks or sleep under the canopy of Heaven are subject to all the disease to which man is heir; so if you are sick and want health please don't come to California to get it but get it before you come here.

POLITICAL AND ECONOMICAL.

This state is certain ly in the grasp of the corporations and monopolies. The Southern Pacific Railway dictates who shall hold the offices or at least a large share of them. It makes the passenger rates and the freight rates as well. Chicago freight is \$500 to \$600 per carload and from Pittsburg, Buffalo and other points it is \$700 to \$900 per car to San Francisco. Do you wonder that the railroads do not favor the Panama Canal? The banks also enjoyed a holiday of about 7 to 8 weeks because the governor was real good, so he declared holidays for the banks from the 28th of October to the 21st of December; when the banks and the governor had a "difference" and the holidays were all off. During legal holidays you might deposit or you may not borrow or withdraw your deposits. Some of the railroads have issued script, some of which is taken at par, while some is taken at a heavy discount. There is no such thing as a Civil Service law here and the politicians of California cannot conceive how such a law can be a benefit in Wisconsin and other states. The pure food law is just about to go into operation and I assure you that all the adulterations which fraudulent manufacturers are not dump upon such states as Illinois, Iowa, Wisconsin and other states which have pure food laws, have been dumped upon the people of the Pacific Coast and this will continue until many thousands have died and others made incurable invalids to satisfy a certain monster whose name is "Greel" then and not until then will public opinion slowly awaken, and when fully aroused it will break its own shackles, tear the hoodwink from its eyes and place the shackles upon that monster who has ruined the lives of many for the benefit of a privileged few. A few days ago certain Travelers' Associations and Merchants' Associations met at San Francisco and declared against the Parcels Post which is likely to be considered by the Sixtieth Congress. These gentlemen condemned the Parcels Post law. Naturally they should, and will protest time and again, as will all Merchant and Travelers' Associations. But what can a few million merchants and traveling salesmen and order-takers do when compared to the many millions of farmers, artisans and other workers the nation over. While I know that it may work a hardship to me and may in time eliminate entirely that "ECONOMIC ASS" now known as a drummer who talks prosperity while he starves one month after losing his job; still his elimination will

in the end be a benefit to humanity,

for after all he is only a "PARASITE" who produces nothing and lives upon the producer and consumer alike. But we are still in the age when we carry a stone as ballast to keep the bag from dropping off our shoulders, for we will learn after a few years more that we have been carrying half a load of wheat and half a load of useless stone to keep our bag balanced. After a little we will wonder why we did not discover that we might have carried part in the front and part in the rear of the bag. And we will exclaim "What fools these Mortals be!" Will the Wisconsin Farmers' Institutes declare for or against the Parcels Post? They should do either one or the other.

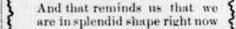

Some authorities estimate that as much as a million pounds worth of gold is lost every year by the Australian mining companies. The gold is hidden in the hands of the nominal gold buyers, who are the accomplices of the dishonest miners, the "fences" in criminal slang. Representatives of the mining companies in Bendigo, where a record number of cases of gold stealing have occurred, have met in conference to consider the best means of dealing with the evil. As a way of checking the thieves, it is decided to establish a register of all the miners employed in the Bendigo district, so that the movements and migrations of dismissed or reasonably suspected men might be traced and observed. In this way it is hoped that the thieves getting employment in other mines—Pall Mall Gazette.

Silver Slippers at Weddings.

"Silver slippers and rose petals are taking the place of the old-fashioned wedding slippers," said a clergyman. "It is a change for the better. DYNAMITE HURLED IN ROME EXCHANGE

BOMB SHAKES DOWN ROOF AND EIGHTEEN BROKERS ARE DUG OUT OF RUINS.

EXPLOSION TERRORIZES CITY.

People Run in All Directions, Fearing Further Outrages by Supposed Anarchists.

ROME, Dec. 31.—A dynamite bomb exploded in the stock exchange of this city today. Up to the present time it has been ascertained that eighteen persons were wounded. Some of the injured are still buried. Firemen, policemen and troops were hurried to the scene and the work of rescue has begun.

It is supposed that the bomb was thrown with the intention of preventing the customary end of the month liquidation.

Exchange Roof Falls In.

The roof of the court yard of the exchange collapsed.

The explosion occurred shortly before 4 o'clock. The exchange is a building in the center of the city. The people in the vicinity were thrown into a state of consternation. The explosion was followed by cries of desperation from within the exchange.

Crowd Flees in Terror.

A crowd, numbering several thousand, began to congregate outside the building. As soon as the police and troops of the exchange were sent to the scene, the crowd fled in terror. The fear of other outrages suddenly possessed the throng and the people broke and fled in the mad rush there was great danger.

The exchange building is closed by a large number of police, and the maintenance of relative order inside the exchange.

Casualties May Be Great.

Ambulances and doctors were summoned to the scene, where they were busy for some time. It is believed that the total casualties will be it is as yet impossible to say. It has been positively determined what was the purpose of the author of the outrage.

The stock exchange is situated in one of the finest ancient remains of the city, the Temple of Neptune and on the south side of the Via dei Fori Imperiali. The temple was built by Hadrian, and is notable for eleven magnificent columns in the Corinthian style, of white marble, each one forty-one feet high. The center portico was built by Agrippa. The roof of the exchange was supported by these famous columns. They were assembled for this purpose by Pope Innocent XII.
