## CANCER IN FISHES.

Experts Say Finny Tribe Is Afflicted with Goitre.

Cancer experts on this side think there must be some mistake in Mr. Taft's special report, which was frequently asked for an appropriation of \$50,000 for the investigation of cancer in fishes. Cable reports make the President say that "close investigation of the subject of cancer in fishes, which are frequently swept away by epidemics of that disease, may give us light upon this dreadful human scourge." Dr. Bashford, director of the Imperial Cancer Research fund, says that there must be some misconception here.

"Fishes are swept away by goitre, not by cancer," he says. "The misconception has arisen because cancer sometimes follows upon goitre."

"I do not mean that cancer does not attack fishes, but the subject which has given rise to Mr. Taft's request for another laboratory is that of goitre, upon which aspect of the question the Imperial Cancer Research fund has been engaged for a long time past. As a result of investigations spread over the entire British empire, which began in 1902, it was found that the disease existed throughout the vertebrate scale."

"In particular it was found that trout, which were kept in hatcheries for stock purposes were very liable to a disease of the thyroid gland, very similar to goitre, and this not infrequently went on to the development of cancer. Cancer, as distinct from that which follows upon goitre, has been found in fish from the sea, but never in any frequency which would justify the theory, a description of the matter of fact, investigators consider it to be established that cancer is not infectious."—New York Sun.

## The Highest Dam.

The Shoshone dam in Wyoming is the highest dam in the world, being 328.4 feet from the base to the parapet. It is located in the profound canon of the Shoshone river, in one of the wildest and most picturesque regions of northern Wyoming. The walls of the gorge are nearly perpendicular and rise nearly 2000 feet above the stream. At its base the dam is 70 feet across; on top it is 175 feet in length and at the base the dam is 108 feet wide. The capacity of this irrigation basin in furlons is something like 148,588,512,000.—Scientific American.

## FORESTER GIVES VIEWS

E. M. GRIFFITH MISQUOTED AS TO CUT-OVER LANDS SPEECH.

Denies Statements Attributed to Him Which Might Be Derogatory to Northern Wisconsin.

MADISON, Wis., May 21.—[Special]—State Forester E. M. Griffith issued this statement today anent the cut-over lands controversy:

My attention has been called to an article in the front page of the Milwaukee Sentinel of the 19th, in which I am quoted as having stated in a talk before the Outdoor Art Association of Milwaukee that all cut-over lands in northern Wisconsin were unfit for agriculture and that the owners of these lands were duping settlers by selling them at \$15 per acre, whereas the state could purchase the same character of lands for the state, and that the attempts of certain companies to induce settlers to purchase such lands at \$15 per acre was "devish" as the lands were not suitable for agriculture, but were strictly forest lands. I stated that duping settlers in this way had often times resulted in giving the state a black eye, and that the cultural section. I did not of course state that all the cut-over pine lands were unfit for cultivation, as such statement would be absurd.

Some four years ago I secured samples of any soils from different sections in Wisconsin and the analysis showed that they varied remarkably in soil fertility. Also having traveled through nearly every county in northern Wisconsin, I know that in some sections there are good farms on sandy soils, while in other sections the settlers are wretchedly poor. It makes all the difference in one word whether a farmer is sure and whether there is loam mixed in with the sand. What I did say was that the hardwood lands of northern Wisconsin were really just beginning to be settled, and that these would be fine farming sections, and I do not believe any one will dispute this.

I was also misquoted in what I said regarding water powers. The article relating to the water powers of the state, Mr. Griffith said the owners were making a bitter fight against the state handling them, and that the people of the state were standing in their own light, as the state now had the power to annul any franchises which had been granted. I said that I thought the water power owners were standing in their own light as a forty-year franchise, which was suggested should be given, seemed better than a so-called perpetual franchise which contained the amendment and repeal clause.

As stated, I was misquoted just enough to convey an entirely wrong impression to the reader. I trust you will give this correction its prominent place in any newspaper. I do not want to in any way retard the settlement of lands which are really suitable for agriculture. I have repeatedly mentioned in my published reports and in articles and addresses that it is one of the principal tenets of forestry that no land should be left idle, and that there is plenty of land in Wisconsin, and nearly every other state which is suitable for forest growth.

Therefore there should be no quarrel between the forester and those who are selling land, and really suitable for farming. The only thing done to the settler and harm to the state when he is induced by false statements to locate on non-agricultural lands, is that he has commenced a soil survey of northern Wisconsin and this is a delayed step in the right direction.

No one has of late years been able to pick the full crop. Its variety is unknown, but the fruit ripens early and resembles the Black Republican.—Seattle Post-Intelligencer.

Watson, a former assemblyman and a prominent resident of this city, died at 8 o'clock this morning from the effects of a paralytic stroke sustained five years ago, from which he never fully recovered. He was 61 years old and held various town and county offices. He was elected to the state assembly in 1888 and again in 1890 and was chairman of the committee on state affairs. In 1902 he was defeated for the Democratic nomination for Congress. He was secretary of the library board and county fair association for a number of years. He also was prominent in lodge circles, having held a high office in the Masons, grand master of Odd Fellows and exalted ruler of the Elks. He is survived by a wife and two daughters.

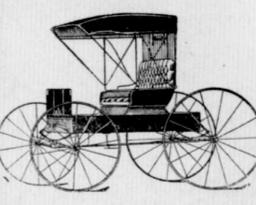

# BIG STEAMER IS SUNK AND MANY ARE LOST

THE GILCHRIST LINER JAMES B. WOOD SINKS THE FRANK H. GOODYEAR.

## BABY TORN FROM FATHER'S ARMS

Survivors Taken on Board the Steamer Wood and Conveyed to Port Huron.

## WOMAN AMONG THOSE RESCUED.

PORT HURON, Mich., May 24.—The steamer James B. Wood, belonging to the Gilchrist Transportation company, solidly with the steamer Frank H. Goodyear, owned by Capt. John Mitchell, going a heavy fog, thirty-five miles north of Point aux Barques, Lake Huron, at 5:30 Monday morning. The Goodyear sank in forty-seven fathoms of water. The Wood reached here early this morning. She had a hole six feet wide in her bow.

Capt. F. R. Heminger of Algonac, Mich., who commanded the Goodyear, Chief Engineer Gibson, Steward Davis Bassett, one wheelman and two passengers, Mrs. Thomas H. Bassett and her daughter of Marine City, Mich., were saved and brought to Port Huron on the steamer Wood. The only hope of the survival of the others who were on board the Goodyear lies in the bare possibility of their having been rescued by the steamer Sir William Siemens which was near the scene of the wreck and is due at Detour and Sault Ste. Marie today.

Many Were Killed. The Goodyear was struck amidships on the starboard side while both of the bows of the Wood were punctured. In a moment it was seen that the Goodyear was doomed, as she began rapidly to fill with water. Every one on board was supplied with a life preserver and every effort was made to man and launch the small boats. But the water poured into the hold so fast that the heavy hatches were forced from their frames by the pressure from underneath and shot into the air in every direction, and the falling hatches spread injury and death among the terrified crew and passengers of the sinking vessel.

With his infant child in his arms, Steward Bassett had almost reached safety in one of the lifeboats when one of the tumbling hatches snatched the baby from his arms. The little one fell into the lake and was drowned despite the frantic efforts of his father to recover it.

Parted Amidships. The cook had just sounded the second call for breakfast when the crash came and many were in the messroom. All rushed on deck and then the boat began to sink. Some jumped into the water and managed to get out of reach of the boat which was fast filling.

Suddenly the Goodyear parted in the center and with sound which could be heard above the whistling of the Wood, sank out of sight, carrying with her all but five of its crew. The bow of the Wood was above in, but a bulkhead resisted the inflow of water, and although some water rushed into the hold, she kept afloat through the efforts of the pumps.

When the Goodyear settled beneath the surface of the water it was evident that she was practically broken in two, the action of the water having completed the destruction begun by the blow received in the collision.

Wood in Danger of Sinking Also. Following the accident, Capt. Gibson of the Wood ordered the lifeboats lowered and gave the crew instructions to make every possible effort to save any of the sailors of the sinking steamer.

Within a short time the yawboat was brought alongside the Wood and Capt. Heminger, Steward Frank Bassett, Mrs. Emma Bassett, Frank Mollick and George Grant were taken aboard, all in an exhausted condition, caused by their exertions to save themselves and the length of time they were in the water.

For more than seven hours the Wood remained at anchor near the scene of the collision, her captain hoping that she would be able to save some more of the crew of the ill-fated steamer of the Goodyear. When the fog rose there was nothing in sight and as his boat was damaged and in danger of sinking, Capt. Gibson returned to this port, arriving here today.

Upon the arrival of the Wood at this port the captain notified his office of the collision and of the sinking of the steamer also notified the owners of the Goodyear of the accident and received orders to bring the surviving members of the crew to Cleveland.

Saw the Goodyear Sink. PORT HURON, Mich., May 24.—"I was standing on deck when I heard the loud whistle," said one of the crew of the Wood. "A moment later the two boats crashed together. I ran forward and surveyed the extent of the damage to our boat and then turned my attention toward the Goodyear and could see that she was sinking fast."

Standing amidships on the Goodyear were the entire crew, huddled closely together, and I saw first one and then another jump overboard. Suddenly the Goodyear made a lurch to one side and went down, leaving a big hole in the water and the suction carried many down with it.

"Next I saw a woman come to the surface with a child in her arms. Then one of the hatches bobbed up and struck her as it descended. I was forced to turn my head from the sickening scene."

"Soon the fog cleared and all I could see were small pieces of floating debris."

No Survivors on the Siemens. SAULT STE. MARIE, Mich., May 24.—[Special.]—The steamer Siemens passed Detroit this morning without seeing any survivors from the Goodyear. It is believed she would have rescued had there been any.

Electric Sparks. During the year 1909, there were handled at the Grand Central station in New York 177,802 trains by means of electric motors, with a total train-minute delay of 38,563. The average detention was only 12 seconds per train, a record said to be unequalled in the history of rail-roading.

Eggs are now preserved by "killing" them with electricity. A new process is electrocuted with a 500-volt current before the eggs are placed in storage, thus lengthening their qualities by several months.

## NICARAGUANS DEFEY AMERICA'S RULING

FORCE FROM GUNBOAT SEARCH UNCLE SAM'S SCHOONER. VESSEL BOARDED WAS FLYING STARS AND STRIPES.

BLUEFIELDS, Nicaragua, May 25.—A Nicaraguan government force from the gunboat Venus today boarded and searched the American schooner Estuero, flying the Stars and Stripes. The action was in defiance of a ruling from Washington that the Venus had forfeited her right of search.

Following the search the Venus and the other Nicaraguan gunboat San Jacinto were seen approaching the Bluefields bluff. The American gunboats Paducah and Dubuque were lying off Bluefields and it was expected here this afternoon that their commanders would take prompt action.

## BRIDE OF 91 YEARS ASKS FOR DIVORCE.

Her 81-Year-Old Husband Is Accused of Having Cruelly Treated and Abused Her.

APPLETON, Wis., May 25.—[Special.]—Age has not intensified domestic felicity in the household of Mr. and Mrs. George Parmann, for the former has not only been placed under bonds to keep the peace, but he has been made defendant in a divorce action in which his wife alleges cruel and inhuman treatment.

Mr. Parmann is 81 years of age and his wife will only need nine years longer to round out the century mark.

Late Tuesday Mrs. Parmann asked Judge Ryan to place her husband under bonds to keep the peace, alleging in her complaint that he threatened to "beat her until she wallowed in her own gore." Soon afterward her attorney filed papers in divorce proceedings. Mr. and Mrs. Parmann have been married only seven years.

## ARRESTED NINE YEARS AFTER BREAKING JAIL.

Missouri Convict, Caught in England for Theft, Is Brought Back to This Country.

NEW YORK, May 25.—Nine years after his escape from a prison in Missouri, M. B. Bates was brought back to this country on his way to St. Louis, arriving here today on the steamship Carmania from Liverpool in charge of two St. Louis police officers, Bate, whose home was in St. Louis, Mo., was serving a sentence of twelve years for robbery when he broke jail. The Missouri authorities heard of his arrest in England for robbery and officers were sent to bring him back on the expiration of his sentence.

## BANKERS DECRY FUND.

Group No. 2 of State Association Sharply Criticize Maintenance of Contingency Covering Fund.

MADISON, Wis., May 25.—[Special.]—Members of Group No. 2 of the Wisconsin Bankers' association at its opening session here today, spoke sharply in condemnation of the practice of some banks in maintaining a contingency fund which was termed a method of covering up clearings, as a violation of the banking law. So serious was the subject regarded that the president referred it to the resolutions committee for further thought.

The high express rate also came in for discussion and bank experts say that the postoffice is a much cheaper and just as efficient and safe a medium for transmitting moneys as the express companies.

Meeting was called to order by President Patrick Bartley of Bloomington. Mayor Schubert gave an address of welcome and E. P. Steensland representing the Madison bankers, also welcomed the visitors to the city.

The report of Secretary C. R. Thomson of Richland Center showed only fifteen banks in the district not controlled with the group and a balance on hand of \$80,94.

## PACKERS IN DEFENSE.

National Packing Company Assails the Validity of Indictments Returned in Chicago.

CHICAGO, Ill., May 25.—The first skirmish in the government's attack on the so-called beef trust began before Judge Landis in the United States district court here today when counsel for the National Packing company and its ten subsidiary concerns assailed the validity of the indictments charging a combination in restraint of trade.

The defendants were represented by Attorneys Ralph C. Crews, George T. Buckingham and Joseph H. DeFrees; the government by District Attorney Edwin W. Sims, Special Assistant District Attorney James H. Wilkerson, Assistant District Attorney Elwood Goodman, and Assistant to the Attorney General Oliver E. Pagan. In his argument Mr. Buckingham alleged:

"That the indictment does not go into facts sufficiently."

"That it does not charge a crime nor into facts constituting a crime."

"That if there was a crime the statute of limitations (three years) had run against it."

"That the indictment charges no interstate commerce transaction."

"That no place in which the combination operated, or had existence, is alleged."

"It is a combination which is illegal; not its acts."

## DRAMA FOR DEAF MUTES OF AMERICA

WISCONSIN SCHOOL AT DELAVAN DEVELOPS NEW FORM OF STAGE PRODUCTIONS.

## NEWER THAN "NEW THEATER."

Classic and Modern Plays Given in Sign Language with Success First Time in History.

## COMPANY MAY TOUR THE STATE.

DELAVAN, Wis., May 24.—[Special.]—A "new theater" that will overshadow the New theater of New York not alone in its novelty but in the idea of uplift, is being developed at the Wisconsin School for the Deaf in this city under the personal direction of Supt. E. W. Walker.

For the benefit of the deaf mutes of Wisconsin and later those of the entire country, methods of presenting the classic and modern drama are being changed and in a short time it is expected that the unfortunates without hearing or power of speech will be able to enjoy the stage as fully and with the same understanding of those who hear and speak.

New Field for the Drama. The "new theater" idea grows out of the novel theatrical performance given at the state school here some weeks ago.

Shakespeare's "Taming of the Shrew" was presented in the sign language by the students, assisted by instructors. The costumes were done with fidelity, a Milwaukee costume designer being required. The performance was so satisfactory that the idea of sign language suggested the development of a new field of the drama.

Negotiations are already under way for the rights to use the best of the modern plays, while the classics will be interspersed. As in the first instance, only students of the school—deaf mutes—and members of the faculty will appear in the casts and the actors will read their lines in the sign language.

Deaf-mutes May Enjoy Stage. "There is apparently no limit to the possibilities of the drama," said Supt. Walker today. "Not only does it show, so far as we have developed the idea, an exceptionally high order of progress among the students who devote all their spare time to it, but it is an excellent educator for them and gives the deaf mutes of the country an opportunity to enjoy the stage."

"Since the original sign-language performance of 'Taming of the Shrew,' we have received hundreds of letters commending the idea and suggesting so many things that we hardly know which to adopt first."

"It has been suggested that we make a tour of the larger cities of the state during the summer vacation, playing to audiences of deaf mutes. This would not rob any of the students of time to do the school work. I am positive that a troupe of this kind would draw immense houses because of the novelty and then become acquainted with the drama in a way that gives them all there is in it."

"However, we have not decided exactly what will be done. The students have taken hold of the idea with great fervor and we have difficulty in restraining some of the most enthusiastic ones from devoting all their spare time to the study and preparation of plays."

At Delavan the sign-language plays are presented in the big assembly hall of the new industrial building or in the gymnasium of the new girls' building, seating 1000 persons, and are spacious enough to accommodate audiences of from 500 to 750 people.

## RIOT AMONG STRIKERS.

State Police Attempt to Disperse Crowd of Italians Who Threatened Other Workmen.

SCRANTON, Pa., May 24.—A riot broke out among the miners at No. 14 colliery of the Pennsylvania Coal company near Pittston today, following an attempt of a posse of state police, headed by Sergt. Menning, to disperse a crowd of Italians who threatened others when a work train reached the colliery.

Sheriff Roda of Luzerne county hurried to the colliery on the outbreak of the trouble and was shot at, but escaped, though a thrown coupling pin gave him a scalp wound.

One foreigner, Peter Sura, was so severely clubbed by state policemen that he may die in the Pittston hospital, where Sheriff Roda hurried him in an automobile, and also had his own wound dressed.

State Trooper Jasper Otfedach was caught under his horse which was felled by a mine breaker at the colliery, a mile away from the scene, where were dispersed when troops arrived.

## YOUNG BOYCE IS FINED.

Chicagoan Who Attacked Father in Hotel Pays \$5—Elder Is Quietly Married.

CHICAGO, Ill., May 24.—Benjamin Boyce, accused by Blackstone hotel officials of disorderly conduct in assaulting his father, W. D. Boyce, the millionaire publisher, pleaded guilty in the municipal court today and paid a fine of \$5. Young Boyce's attack is said to have been precipitated by his father's announcement that he would be married on June 1 to Miss Virginia D. Lee. The elder Boyce surprised his friends by quietly being married Monday night. With his bride he is now believed to be on his way to Montreal or Quebec. Mr. Boyce and his former wife, mother of Benjamin, are divorced.

A telephone operator found him at midnight wandering along the drive hunting for his home as eagerly as his friends had hunted for him. The boy knew that the owner of so valuable a dog would advertise his loss in The World, so he had no difficulty in finding Bully's home for him early the next day.—New York World.

## ESCAPE WATERY GRAVE

LAUNCH PARTY IS TOSSED ABOUT ON STORM-LASHED LAKE.

Evanston People Are Saved After Their Craft Is Dashed Upon the Beach.

KENOSHA, Wis., May 23.—[Special.]—B. S. Stewart, Mrs. R. S. Stewart, Miss G. B. Stewart and Russell E. Grenn, all of Evanston, narrowly escaped death in the lake north of Kenosha Sunday night and the four people who were passengers on a small gasoline launch were rescued from the lake by members of the Kenosha lifesaving crew after an hour's fight with an angry sea.

The boat was owned by Stewart and had started from Racine to Evanston. Two miles north of Kenosha the launch was struck by a squall and for more than two hours she floundered about before her plight was discovered by the lifesaving crew, and Capt. Frank Fountain and his men went to the rescue.

The boat at this time was practically on the beach and Stewart was making an effort to save the two women, who were drenched from the heavy seas.

The members of the party were taken aboard the surf boat and brought to Kenosha, where they were given dry clothes and their shoes. They returned to their homes this morning.

The launch was pulled off the beach later and towed into the Kenosha harbor. Stewart had feared a heavy sea and for this reason had been keeping a course close to the beach and he got so close that a great wave struck the little boat and drove her on shore.

At the time of the accident a rainstorm was on for the area and the launch was the members of the party was not seen by the lifesavers earlier.

## SON OF MILLIONAIRE ENDS LIFE AS PAUPER.

Albert J. Snell Dissipates Fortune and Dies in Chicago After Working as Messenger.

CHICAGO, Ill., May 23.—Albert J. Snell, son of the millionaire Amos J. Snell whose murder here in 1888 created a widespread sensation, was found dead in bed at a cheap rooming house here today. He was 50 years of age. He inherited a fortune from his father, and is said to have set a fast pace while the money lasted. He drifted steadily downward of late years and for several years has made a hand-to-mouth living, running errands on the docks.

## GIRL MOTORIST IS CONFINED TO JAIL.

Theodora Stark, 18 Years Old, Charged with Manslaughter After Running Down St. Paul Man.

ST. PAUL, Minn., May 23.—A charge of manslaughter was filed by the police today against Miss Theodora Stark, the 18-year-old Minneapolis girl, who, while driving an automobile, ran down and killed S. B. Shotwell, a well known St. Paul broker, in this city Sunday night.

Miss Stark, with her sister, spent the night in the county jail, and will be probably arraigned this afternoon.

## SMASHES MAY OPTION.

Prominent Chicago House Sends Down Price of Wheat 4 Cents to \$1.06 1/2.

CHICAGO, Ill., May 23.—A determined drive at prices in the wheat pit today, led by a prominent Chicago house, smashed the quotations for the May option 4 cents to \$1.06 1/2 a bushel. Heavy selling by foreigners through agents on this market had much to do with the big slide downward. Business, however, was chiefly in the September and other near futures.

The Chicago firm, which was so conspicuous on the selling side, has been popularly believed to be opposed to an Albany, N. Y., speculator who was credited with having a tight hold on the bull side of the May deal here. The Chicago firm adopted the unusual course of bringing huge quantities of wheat here from Duluth and settling by delivering the actual grain rather than pay differences on prices fixed by comparatively light transaction in the pit on change.

The stream of wheat by water from the north continued uninterrupted today, although somewhat delayed by a windent blocking the Neeshib channel near Sault Ste. Marie.

## CENSUS FINDS SISTER.

Beloit Woman Gets Word from Long Lost Relative Through Agency of Uncle Sam.

BELOIT, Wis., May 23.—[Special.]—Mrs. Guy Rohles has just discovered the whereabouts of her sister, Mrs. Kathryn Blake, whom she has not seen for forty-two years and from whom she has not heard for fifteen years. When a census enumerator called on Mrs. Rohles, she asked him if it would be possible to get the address of her sister through the census bureau. He advised her to write to congressman Cooper. She did so and received from him a list of names. Following this up, she heard from her long lost relative in Ottumwa, Ia.

## TAFT IS OUT OF RACE.

President's Brother, It Is Believed, will Not Enter Senatorial Contest in Ohio.

WASHINGTON, D. C., May 23.—Charles P. Taft, a brother of President Taft and at present a guest at the white house, will not take part personally in this year's campaign in Ohio. He will sail for Europe next Saturday and will not return until just before election time. This indicates, it is believed here, that he will not enter the senatorial race against Senator Dick.

## DRY DOCK DEWEY SINKS

GOES UNDER WHEN ABOUT TO RECEIVE TORPEDO BOAT.

Due to Carelessness Rather Than to Deliberate Purpose of Japs to Do Damage.

MANILA, May 25.—It is the general opinion that the sinking yesterday, of the dry dock Dewey, was due to carelessness rather than to a deliberate purpose upon the part of the station employees, who are Japanese, to cause damage.

The experts declare that the great floating dock, which was towed here from the United States at much expense, will be saved despite the likelihood that it will be submerged before tomorrow morning.

The port side, including the pumps, was submerged today and partly resting on the bottom. The starboard was still exposed but was settling slowly. It is doubtful whether the starboard pumps alone could avail much. Meantime the tug "Piscataqua" was waiting to assist when the sea was calmer.

The electrical machinery which operates the valves is certainly badly damaged.

## COMET IS SPLITTING UP?

Arizona Astronomer Says Astral Wanderer Is Dividing and Will Soon Disappear.

CHICAGO, Ill., May 25.—Division of the comet's head as reported from Arizona this morning was not detected by observers here Tuesday night.

"What we did see," said Prof. Edwin B. Frost of Yerkes observatory, "was that the head was much brighter than it has been, and there was cyanogen gas in the tail, along with ordinary hydrocarbon. If the head is divided as reported it will probably show in photographs which we took Tuesday night, but which have not yet been developed."

The report of the division came from Tucson, Ariz. Dr. A. E. Douglas of the University of Arizona declares he observed two parts of the head of the comet, and he predicted the ultimate destruction of the astral wanderer. He said his computation indicated that the bright part of the head was about 3000 miles ahead of the other part. Dr. Douglas calls attention to the fact that the comet will divide into four parts and entirely disappear.

## SUICIDE ENDS WORRY.

Janesville Superintendent of Gaslight Company Shoots Himself with an Old Revolver.

JANESVILLE, Wis., May 25.—[Special.]—William Farmer, a Mason, a member of the Wisconsin consistory and a prominent Odd Fellow, committed suicide this morning.

Farmer for twenty years or more has been connected with the gas light company of this city, most of the time as street superintendent.

Mrs. Farmer stepped out into the yard and during her absence Farmer went into a bedroom and shot himself with an old revolver which has been around the house for many years. He recently had words with the manager of the gas company and it is thought that worry caused his act.

## HUSBAND IS ACCUSED.

Chicagoan Charged with Beating and Killing Wife Because She Didn't Have Supper Ready.

CHICAGO, Ill., May 25.—Because she did not have supper ready for her husband, Mrs. Frank Lewandowski is dead and her husband will be charged with murder, according to the police. Mrs. Lewandowski died today and the police say her death was due to a beating given her by her husband Monday night, when he came home and found his supper not ready. Mrs. Lewandowski's face and body were bruised and she suffered internal injuries, according to the hospital physicians.

## LA FOLLETTE COHORTS TO GATHER.

Madison State Journal Says the Leaders Differ as to Rendezvous.

MADISON, Wis., May 25.—[Special.]—The State Journal today says that a big pow-wow of La Follette men is being arranged. It will probably be held in Madison and the date will be decided upon by the senior senator. The gathering will be either after Congress adjourns or before if the senior senator and others can arrange to come.

The idea originated in the Cummings gathering in Des Moines recently and the coming convention of Republicans in Milwaukee spurred it up.

Friction is said to have developed within the La Follette faction over the place of meeting. F. E. McGovern wants the meeting to be held in Milwaukee and other La Follette men and La Follette himself want it held in Madison.

It is most likely the meeting place will be in Madison.

## SHOT SINKS THE KATAHDIN.

Shell Fired in Practice Misses Target and Hits Ram.

WASHINGTON, D. C., May 25.—The United States harbor defense ram Katahdin has been sunk in the Potomac river by a misdirected shot fired in target tests.

Information of this sensational result of the tests now in progress down the river was received here Tuesday from a reliable source, but whether the Katahdin was sunk Tuesday or earlier in the tests cannot be learned.

The shot which sunk the vessel missed the heavily armored target attached to the vessel's side and plowed through the hull nearly amidships.

It is not known whether there was anyone on board the Katahdin at the time. The ship, while old in point of service, is still listed as a serviceable vessel.

Chalmers of 65 Central place, Brooklyn, who sought from Mayor Gaylor the other day permission to preach in the streets in the Jewish quarter to convert the Jews. The mayor asked him in return if he didn't think the Jews had had a pretty good religion for some time.

## GOMPERS IS SATISFIED

Willing to Work for Labor Federation and Is Not Seeking Cabinet Position.

WASHINGTON, D. C., May 25.—"I would rather be president of the American Federation of Labor than to hold any other office on earth," declared Samuel Gompers, president of the American Federation of Labor, in assuring the House committee on labor today that he had no ambition to become secretary of the proposed department of labor, the establishment of which he was urging.

"The President should have a man in his cabinet who knows labor conditions, one not necessarily risen from the ranks, but who is still of the ranks," said Mr. Gompers.

"The creation of a department of labor will help to solve the greatest question of modern times—the labor question. It will solve one of the problems of life; help to dignify labor and to secure more even-handed justice for workers."

## TO REGULATE SALOONS.

Speakers at Liquor Dealers' convention in Cincinnati Discuss Model License Systems.

CINCINNATI, O., May 25.—Expositions of model license systems and reviews of conditions in various states were held by the convention of the National Wholesale Liquor Dealers' association today. W. J. Friday of Pittsburgh upheld the workings of the Brooks license law in Pennsylvania and declared that "the kind of places that are conducted under the last of its provisions, have assisted in preventing the attempts of the anti-saloon league to obtain the enactment of a strictly local option law."

## ROOSEVELT IS HONORED.

Presented with Address Setting Forth Hopes of Parliamentarians for Universal Peace.

LONDON, May 25.—A deputation from the British group of the inter-parliamentary union was received by Mr. Roosevelt today. The deputation was headed by Lord Wakefield and presented the former President with an address setting forth the aims of the union and the hopes of the British group for universal peace. In reply Mr. Roosevelt expressed his sympathy with the cause presented by the visitors. He spoke briefly, as his throat is still bothering him somewhat and his voice is not normal.

## PROF. ROBINSON DEAD.

Leading Chemist and Health Authority Succumbs to Bright's Disease in Portland, Me.

PORTLAND, Me., May 25.—Franklin Clement Robinson, a leading chemist and health authority, died here today of bright's disease. Prof. Robinson was born in 1852, was graduated from Bowdoin college in 1875 and for two years studied chemistry at Harvard. He was professor of chemistry at Bowdoin and state assayer. He was formerly president of the American Public Health association and was an author of several standard textbooks.

## BROKERS GO TO JAIL.

Five Sentenced for Bucketshop Operations Surrender and Begin Terms in Ohio.

CINCINNATI, O., May 25.—Louis W. Foster, Ed Hell, Walter Campbell, J. M. Scott and Arthur J. Baldwin, the five members of the O'Dell Brokerage company, who were sentenced to jail on charges of using the mails for bucketshop operations, surrendered to United States Marshal Eugene Lewis today. They were taken to the county jails in Dayton and Troy, O.

## CRUSHED UNDER STONE.

Just After Cautioning His Helpers to Beware of Danger, Rich Farmer Forgets Himself.

LONE ROCK, Wis., May 25.—[Special.]—Ever Everson, a prosperous farmer, was instantly killed Tuesday while undermining a large rock. It was standing against a cliff and fell, mashing him under it. He had just cautioned his men to be careful. His wife and three children survive him.

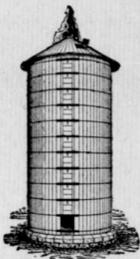

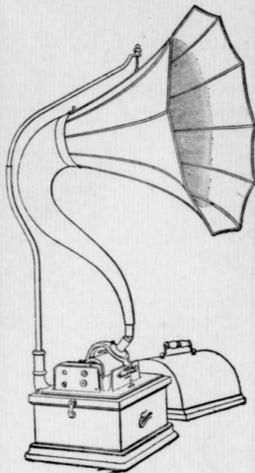

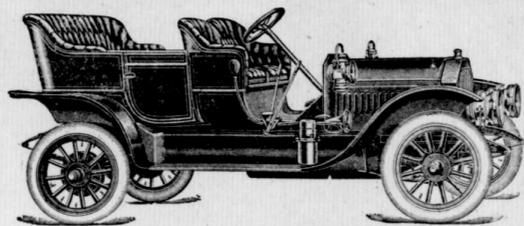
